- 2. Community Transportation Program Bus Stop Consultation
  - Report from Sam McFarlane, Accessibility Coordinator

That the Middlesex Accessibility Advisory Committee recommend the following design specifications regarding the construction, renovation or replacement of bus stops and shelters as they relate to the Middlesex County Community Transportation Project:

- Bus stops to incorporate a paved, firm, level surface with a clear landing space for accessible bus lift measuring 1500mm wide by 1220mm long. Additional recommendation includes the installation of a 1500mm wide by 1220mm long hashed caution area (the hashed caution area and clear landing space can act as one).
- Further, there should be a paved, firm and level clear exterior path of travel connecting the bus stop pad to the sidewalk at a minimum of 1500mm wide. If bus shelters are to be installed, they should be located on the paved, firm and level bus stop pad.
- Incorporate clear floor space to accommodate a person using a wheelchair or scooter measuring 1220mm long by 760mm wide if the bus shelter is not enclosed. If the bus shelter is enclosed, recommend a 2000mm wide and 2000mm long clear turning radius for mobility device users.
- Additionally, if there is a doorway/entryway installed it should be minimum 965mm wide.
