1. CALL TO ORDER AND WARDEN'S REMARKS

Warden Warwick called the meeting to order at 1:00pm. Warden Warwick addressed Council as follows:

"When looking at the agenda for this meeting, I reflect that so many of our successful projects are a result of partnership and collaboration.

Using this lens, I would like to comment on two issues -- child care and transit.

I would think it safe to say that those two issues have been more affected by the pandemic than many others. However, the increased awareness brought to these areas is starting to reap benefits.

The struggles to provide quality childcare throughout the pandemic put a spotlight on the inequity of compensation to the early-years educators who work with our most precious population, our infants and toddlers.

The Canada Wide Early Learning and Child Care agreement between the provincial and federal governments will ultimately be a strong part of our recovery. The following is a quote from The Childcare Resource and Research Unit:

"The recognition that reliable, affordable, high quality child care is essential not only for our families, children and women's equality, but also for Canada's economy and future prosperity."

The use of the federal funding opportunity to support the retention and recruitment of high quality child care and early years is another great example of collaboration. The use of these federal dollars to encourage and provide future educators an opportunity to receive a quality education, in our own county, with a bursary will be a game changer for ten potential students and is a real solution to the real shortage of early years educators.

On a personal note, I feel my mother looking over my shoulder at these times. As a passionate former educator at Fanshawe ECE program, she would have been so pleased and proud of these innovations.

The investment of provincial and now recently federal dollars in our community transportation systems has been welcomed and encouraging. We are now at a crucial stage where we can assess what our next steps are.

We know that southwestern Ontario is one of the most ideal locations in Canada for piloting a transit system. It is the responsibility of municipal governments of Southwestern Ontario to support and grow a local transit system that can be used as a model across Canada.

Continued funding for community transportation will allow communities to strategically plan for the future and make long term investments in their transit services. The grant we see in front of us today is a project that the federal government has earmarked 250 million dollars for, to support the development of locally driven transit solutions that will help people living in rural communities. Our successful grant application will explore an on demand transportation system in the County of Middlesex.

Last week SCOR awarded Dennis Kar and Dillon Consulting the successful bidder for the RFP for SCT's application to the same funding.

At present Southwest Community Transit headed by SCOR works with eight local transit systems. The goal is to keep connecting these transit systems and to keep identifying challenges and opportunities.

At AMO SCOR will be asking the province to either directly or indirectly take a leadership position through provision of supports to regional transportation networks such as SCT. I congratulate the County of Middlesex and SCOR for their successful applications to the Rural Transit Solutions Fund. I also would like to see communication and collaboration through out the funding period in order to determine next steps that should be taken to identify funding gaps.

County Council should be very proud of its staff and administration for continuing to make our County a better place for everyone. This is one of the most rewarding parts of the municipal government and our council should also be proud of itself for continuing to be innovative and having a vision for the future."
