1. CALL TO ORDER AND WARDEN'S REMARKS

Warden Burghardt-Jesson called the meeting to order at 1:00 p.m.

Warden Burghardt-Jesson addressed Council as follows:

"The last 10 days have been to say the least, troubling. Our nation was rattled with the discovery of 215 lost but now found Indigenous children. The discovery has served as a reminder that we cannot hide from a painful and horrifying past. We as a collective nation must acknowledge the role played in this cultural genocide. I am sure you in your personal reflections and in your local municipalities have grieved and honoured the 215 little lives that have been lost. Here at the County, the flag has been flying at half-mast.

And now we are facing the Sunday event that happened in our backyard. I really have no words as to how we begin to process what happened. I can share when Chief Williams confirmed this tragedy was in fact a targeted hate crime, I felt physically ill. Far too many times we have witnessed from a far crimes of this nature, in other countries, in other communities. I would hope we are not so naive to think racial prejudice does not exist here. After all we have seen signs, heard stories of troubling signs. However, a brutal, targeted attack on a family just out for an evening stroll leaves me gob smacked. We all need time to

process this and I suspect as more details are released, it will for a time become more difficult to grapple.

These 2 events, while decades apart in occurrence, are bound together by hatred. A hatred I do not understand or cannot fathom. I have reached out to Mayor Holder and expressed our sympathies and support on behalf of everyone in Middlesex County. Our flag will be flying at half-mast until Friday in honour of this family.

As leaders we are looked to for continuity and comfort. It is hard to offer that during times when we are ourselves are hurting, burdened and troubled. But to our communities I offer this...we must acknowledge what has happened and we MUST be part of a better future. In my Lucan Biddulph office I have a sign that reads Do Better. We must be part of a present and future where we do better. We must call out hate when we see it. We cannot be idle bystanders any longer. When we hear inappropriate language referring to a culture, when a joke is shared that shouldn't be, speak up. If we don't how can we be part of facilitating change? Hatred grows and it's easy when we don't stop the growth. Ignorance leads to fear, fear leads to anger, anger leads to hate. Let's stop the cycle at ignorance. Love will always prevail...We must lead with love.

We often look at past leaders and influences for inspiration at a time like this. I was empowered when I found this quote from Martin Luther King Jr. I felt that it described our community today and offered the hope that leading with love provides.

*"Hatred paralyzes life; love releases it.
Hatred confuses life; love harmonizes it.
Hatred darkens life; love illuminates it."*

Please join me in a moment of silence to honour the 215 little lives and the family lost in London on Sunday.

I do want to take another moment to formally congratulate Councillor Vanderheyden on officially becoming the President of FCM. Joanne this is an incredible accomplishment. Your year ahead will be full of challenges and opportunity. I know that Strathroy-Caradoc, Middlesex County and now municipalities across the country will be stronger for your leadership. Congratulations...

I also want to mention Councillor Elliott, as she held onto her seat on the Board. Our region is well represented!"


